IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

FA STATED HE WAS CONCERNED WITH THE LARGE POSITION AND PERFORMANCE OF THE GABELLI EQUITY TRUST AND ROYCE VALUE TRUST STOCKS HELD IN CLIENT'S ACCOUNT. ACCORDING TO FA, HE VISITED WITH CLIENT AT HER HOME AT WHICH TIME HE RECOMMENDED LIQUIDATING 1/2 OF THE HOLDINGS. AT THE CONCLUSION OF THIS CONVERSATION, FA STATED SHE AUTHORIZED LIQUIDATING A SMALLER



PORTION OF THE HOLDINGS AND THE SHARES WERE LIQUIDATED AS CLIENT INSTRUCTED. AT THE TIME OF THE TRANSACTIONS (FEBRUARY 2008) CLIENT WOULD HAVE BEEN PROVIDED WITH TRADE CONFIRMATIONS AND THE ACTIVITY WAS REFLECTED ON CUSTOMER ACCOUNT STATEMENT. FA INDICATED HE HAS NEVER CONDUCTED ANY ACTIVITY IN CLIENT'S ACCOUNT WITHOUT HER INSTRUCTION AND AUTHORIZATION. I HAVE ALSO REVIEWED THE MUTUAL FUNDS HELD IN ACCOUNT AND CAN CONFIRM THE DIVIDENDS ARE SET UP TO PAY INSTEAD OF REINVEST. ADDITIONALLY, CLIENT DOES CURRENTLY HAVE A MONEY MARKET ACCOUNT WITH A BALANCE (AS OF TODAY AND NOT INCLUDING ANY OUTSTANDING CHECKS) OF APPROXIMATELY \$8,715.30. THE FUNDS HELD IN EDWARD JONES MONEY MARKET ACCOUNT ARE NOT AUTOMATICALLY SENT TO CLIENT'S BANK ACCOUNT. FA STATED CLIENT DOES HAVE CHECKS ON EDWARD JONES MONEY MARKET ACCOUNT WHICH SHE CAN WRITE OR CLIENT MAY CONTACT THE BRANCH OFFICE DIRECTLY IF SHE WISHES TO HAVE FUNDS SENT TO BANK ACCOUNT. BASED ON OUR REVIEW, IT DOES APPEAR THE FEBRUARY 2008 ORDERS TO LIQUIDATE A PORTION OF HOLDINGS IN GABELLI EQUITY TRUST AND ROYCE VALUE TRUST WERE THE RESULT OF DISCUSSIONS WITH FA AND WERE PLACED WITH CLIENT'S AUTHORIZATION. CLAIM DENIED.
