**Broker Statement**

This allegation is at most, a clerical error. The client had an account custodied with UBS. In 2019 he requested that UBS be terminated as the outside money manager so that he could transfer this account out of UBS, and we followed these instructions. At that time, we advised him that due to our non-management he should, and was able to, transfer the account out of UBS. More than 3 ½ years later, Fidelity sent UBS an email requesting that we close out the account and sell the assets. As we routinely tell our clientele, UBS cannot accept buy or sell orders via email. The client did not realize that his order would not be processed until he later made it orally, and expressed dissatisfaction with the delay. I believe I provided him with the same attention and high level of service I provide all of my clients.
