What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

After consulting family members and her CPA, customer contacted the RR to authorize the sale of mutual funds and the transfer of the proceeds from that sale into an annuity with the intent of immediate annuitization, which would not have resulted in surrender charges. Customer, however, later changed their mind and requested that the proceeds of the mutual fund sale used to fund the annuity be returned. All funds were returned to the member in cash and surrender charges were waived by the firm.
