IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Regulator Statement On March 13, 2014, the Office of Financial Regulation entered a Final Order adopting the Stipulation and Consent Agreement against Alexander Tommasino. Alexander Tommasino, admits, accepts, and consents to the findings by the Office. The Office found that Alexander Tommasino failed to send clients itemized invoices and maintain a written advisory contract. Alexander Tommasino agreed to pay an administrative fine of \$4,000.

Allegations: THE OFFICE OF FINANCIAL REGULATION ("OFR") ALLEGED THAT THE FIRM HAD CUSTODY OF CLIENT ACCOUNTS AS DEFINED IN RULE 69W-600.0132(1)(A)1.B OF THE FLORIDA ADMINISTRATIVE CODE (THE "FAC") AND DID NOT COMPLY WITH THE REQUIREMENTS OF RULE 69W-600.0132 OF THE FAC BECAUSE IT DEDUCTED ADVISORY FEES FROM ACCOUNTS WITHOUT SENDING AN ITEMIZED INVOICE TO CLIENTS. THE OFR ALLEGED THAT THE FIRM FAILED TO FILE FINANCIAL STATEMENTS THAT WERE AUDITED AND MAINTAIN A CERTAIN MINIMUM NET CAPITAL, WHICH IS A REQUIREMENT OF FIRMS THAT HAVE CUSTODY. THE OFR ALLEGED THAT THE FINANCIAL STATEMENTS WERE NOT PREPARED IN ACCORDANCE WITH GAAP. THE OFR ALLEGED THAT THE FIRM'S FORM ADV DID NOT ACCURATELY REFLECT THAT THE FIRM HAD CUSTODY. THE OFR ALSO ALLEGED THAT THE FIRM FAILED TO ENTER INTO ADVISORY AGREEMENTS THAT WERE WRITTEN.
