Broker Statement

In the complaint letter, the only reference to Mr. Taber's name is with regard to the client's "discussions that classified him as (1) wanting moderate risk and (2) growth", and the recommendations for mutual fund purchases held as the result of such classification, including reinvestment of dividends. The consumer never stated or suggested that the risk classification was inappropriate or that they were displeased with the mutual funds sold.

Based on Mr. Taber's interpretation of the letter, the consumer-initiated written complaint is directed at HSBC Securities, Inc. and their lack of attention to the investor's investment accounts after he resigned from the firm in May 2013. It should further be noted that this event represented no loss in principal value to the consumer and the complaint has since been denied.
