### What is included in a IAPD report?

### Where did this information come from?

THE CLIENT MADE SEVERAL PURCHASES ON 6/20/06 INCLUDING C AND BP. THE FA INDICATES THE CLIENT AUTHORIZED ALL THE PURCHASES AT THE TIME OF THE TRANSACTIONS. OUR RECORDS INDICATE THE CLIENT WAS SENT CONFIRMATIONS AND MONTHLY STATEMENTS. ADDITIONALLY, THE CLIENT RECEIVED DIVIDENDS ON EACH SECURITY AND THE 1099 REFLECTED THE DIVIDENDS. THE CLIENT PURCHASED TM WITH PROCEEDS FROM A CALLED TOYOTA BOND ON 7/21/08. THE CLIENT ALSO RECEIVED A CONFIRMATION, STATEMENTS AND DIVIDENDS ON TM. UPON REVIEW OF THE CLIENT'S EMAILS TO THE FIRM, SHE WAS CONCERNED WITH THE ISSUES SURROUNDING C, BP AND TM; HOWEVER, THE RECEIPT OF THE COMPLAINT IS THE FIRST TIME SHE ALLEGES THE PURCHASES WERE NOT AUTHORIZED. PER THE CLIENT'S REQUEST, THE ACTIVITY IN HER ACCOUNT HAS BEEN REVIEWED. SHE TRANSFERRED IN APPROXIMATELY \$472,081 IN ASSETS AND CASH IN 2006. THE CLIENT HAS WITHDRAWN APPROXIMATELY \$440,000 THROUGH DEBIT CARD ACTIVITY, CHECKS WRITTEN ON AND ISSUED FROM THE ACCOUNT, AND AUTOMATIC WITHDRAWALS. UPON REVIEW, THE INVESTMENTS APPEAR TO BE WITHIN THE SCOPE OF THE CLIENT'S INVESTMENT OBJECTIVES. THE TRADES WERE AUTHORIZED BY THE CLIENT. WHILE WE UNDERSTAND THE CLIENT'S DISAPPOINTMENT WITH THE VALUE OF HER ACCOUNT, THE VALUE IS ATTRIBUTED TO CIRCUMSTANCES BEYOND OUR CONTROL, THE CLIENT'S WITHDRAWALS AND MARKET FLUCTUATION, WHICH IS A RISK ASSOCIATED WITH INVESTING. THE CLIENT'S REQUEST FOR REIMBURSEMENT IS RESPECTFULLY DENIED.
