**Allegations:** William Ellery Sweet, III, CRD No. 1004942 ("Sweet") and Blair Allen Quinn, CRD No. 4722738 ("Quinn") are managing members of the firm, collectively referred to as respondents. Division Staff conducted an examination of the Alpine Wealth Advisors, LLC books and records in 2012. The firm was subject to an examination in 2021 and Staff identified the following issues in the deficiency letter dated September 30, 2021: failure to cure issues identified in the deficiency letter dated September 30, 2012, failure to file and update disclosure documents, performance of unlicensed investment adviser representative activity, failure to maintain and preserve books and records in an easily accessible place, and failure to respond to Staff requests for books and records in a timely manner.
