IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Employing firm when activities occurred which led to the complaint: NBC SECURITIES, INC.

Allegations: CLIENT PURCHASED AXA EQUITABLE VARIABLE ANNUITY IN JANUARY 2008 AND MADE INITIAL WRITTEN COMPLAINT TO AXA IN FEBRUARY 2008. THE FIRM'S DETERMINATION AT THAT TIME WAS THAT THE COMPLAINT DID NOT ALLEGE SECURITIES LAW VIOLATION AND CLAIM FOR COMPENSATORY DAMAGES IN EXCESS OF \$5,000. CLIENT ALLEGED THAT HE WANTED JOINT ANNUITANTS ON THE CONTRACTS WHICH WAS NOT POSSIBLE. ALSO ALLEGED THAT HE WAS TOLD ANNUITIES CONTAIN GUARANTEES FROM THE STATE OF FLORIDA AND SIPC. NO EVIDENCE OF ANY SUCH GUARANTEES MADE BY RR. CLIENT DID NOT SEEK SURRENDER OF CONTRACT AS HE WAS PLEASED WITH TERMS OFFERED BY AXA. CLIENT WROTE ADDITIONAL COMPLAINT LETTER TO AXA ON 5/4/2011 WHICH THE FIRM DETERMINED TO ALLEGE COMPENSATORY DAMAGE OF \$5,000 OR GREATER.
