I did not manually sign the signature. The policy was issued. The client later moved to a different state for a new job. Due to their new job benefits, they cancelled other policies that they no longer felt they needed because of overlapping coverage. They found out that cancellation of the policy in question would include a significant early cancellation penalty because it was only held for two years. Subsequently, they filed this complaint. The policy was reversed and all premiums were returned to client.
