What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

SEVERAL OCCASIONS. DURING THESE CONVERSATIONS, IR WAS INFORMED BY THE HUSBAND, IN THE EVENT OF AN EMERGENCY, HIS WIFE COULD REQUEST A CHECK BE ISSUED. OUR RECORDS DO REFLECT CHECKS ISSUED ON 2/28/05 (\$40,000) AND ON 3/11/05 (\$9,000). ACCORDING TO IR, HE WAS INFORMED THE CHECKS WERE BEING USED TO BENEFIT THE HUSBAND AND THE HEIRS OF HIS ESTATE (FLY THE CHILDREN IN DUE TO FAILING HEALTH). WHILE IT DOES APPEAR THE CHECKS WERE ISSUED ON THE INSTRUCTION OF THE WIFE, THE CHECKS WERE MADE PAYABLE TO THE HUSBAND ONLY AND MAILED TO THE ADDRESS OF RECORD. WHILE WE UNDERSTAND CONCERN REGARDING THIS MATTER, IT DOES APPEAR THE CHECKS WERE MADE PAYABLE TO THE HUSBAND AND WERE BEING USED FOR BOTH HIS BENEFIT AND THE BENEFIT OF HIS NAMED HEIRS. AT THIS TIME AND WITHOUT ADDITIONAL INFORMATION, EDWARD JONES WOULD RESPECTFULLY DENY A REQUEST TO REIMBURSE THE ESTATE OF THE HUSBAND FOR THE AMOUNT WITHDRAWN DURING THE TIME IN QUESTION IN THE TOTAL AMOUNT OF \$49,000. IF ATTORNEY HAS ADDITIONAL INFORMATION REGARDING THIS MATTER, PLEASE FORWARD TO OUR ATTENTION FOR FURTHER REVIEW AND CONSIDERATION.
