IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement ACCORDING TO FA, CLIENT CONTACTED HIM PRIOR TO LEAVING TOWN FOR BUSINESS IN EARLY OCTOBER 2008. FA STATED DURING THIS CALL THE DECISION WAS MADE TO LIQUIDATE THE STOCKS HELD IN THE CLIENT'S SINGLE ACCOUNT [ACCT #] AND REINVESTMENT OPTIONS WOULD BE DISCUSSED WHEN THE CLIENT RETURNED FROM HIS TRIP. IT IS OUR UNDERSTANDING THE MUTUAL FUNDS HELD IN THE CLIENT'S CHILDREN'S ACCOUNTS WERE ALSO REVIEWED AND THE FA HAS INDICATED THE CLIENT AGREED TO CONTINUE HOLDING THE DAVIS FUNDS AND HARTFORD CHECKS AND BALANCES FUND. FA STATES THAT DUE TO THE EQUITY EXPOSURE OF THE AMERICAN FUNDS HELD IN THE CHILDREN'S ACCOUNTS, THE DECISION WAS MADE TO EXCHANGE ALL FUNDS INTO THE CASH MANAGEMENT TRUST OF AMERICA. ACCORDING TO FA, A FOLLOW UP MEETING OCCURRED AT THE CLIENT'S OFFICE ON OCTOBER 29, 2008. FA STATED THE CLIENT'S GOALS FOR HIS SINGLE ACCOUNT WERE REVIEWED; HOWEVER, THERE WAS NO CONVERSATION RELATING TO THE CHILDREN'S ACCOUNTS. IT IS OUR UNDERSTANDING IT WAS DURING A CALL ON DECEMBER 2, 2008 THAT THE CLIENT EXPRESSED CONCERNS RELATING TO THE PERFORMANCE OF INVESTMENTS HELD IN HIS ACCOUNTS AND MANY TRANSACTIONS WERE MADE TO MOVE HIS FUNDS TO MONEY MARKET POSITIONS. BASED ON OUR REVIEW, IT APPEARS THE CLIENT'S ACCOUNTS WERE HANDLED APPROPRIATELY AND WE WILL NOT BE MAKING ANY ADJUSTMENTS. CLAIM DENIED.
