IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "settled" matter generally represents a disposition wherein the parties involved in a dispute reach an agreement to resolve the matter. Please note that Investment Adviser Representatives and firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement

THE BONDS IN QUESTION WERE ACTUALLY PURCHASED IN 2005 AND NOT 2004. ALL OF THE NOTES AND BONDS CARRIED THE ESTATE FEATURE, WHICH MEANT THAT THE BENEFICIARIES WOULD RECEIVE THE FULL FACE AMOUNT OF THE INVESTMENT IN THE EVENT THE CLIENT WAS TO PASS AWAY. TWO OF THE BONDS WERE CALLED IN 2007 AND THE OTHER TWO WERE SOLD IN 2010. SINCE THE POA ON THE ACCOUNT WANTED THESE INVESTMENTS RECTIFIED BECAUSE OF THE MATURITIES, THERE IS REALLY NOTHING TO DO BECAUSE ALL OF THE BONDS HAVE BEEN CALLED OR SOLD. WE FELT THAT THESE BONDS MET THE CLIENT INCOME OBJECTIVE AND WERE SUITABLE FOR HER ACCOUNT.
