IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: THE CLIENT STATES THAT THE FORMER FA RECOMMENDED THAT HE PURCHASE FNMA AND FREDDIE MAC PREFERRED STOCK WITH THE PROCEEDS FROM THE SALE OF PUTNAM FUNDS. THE CLIENT STATES THAT A WEEK AFTER PURCHASE THE PRICE DROPPED TO \$17.00 PER SHARE AND THE FA INDICATED IT WAS STILL A GOOD INVESTMENT. THE CLIENT STATES THAT ON 9/13/08 SHE LEARNED THAT BOTH PREFERRED STOCKS WAIVED THEIR DIVIDENDS AND THE SHARES WERE NOW TRADING AS COMMON SHARES WHICH THE CLIENT CLAIMS ARE ESSENTIALLY WORTHLESS. THE CLIENT CLAIMS LOSSES IN THE AMOUNT OF \$160,028.95 AND LOST DIVIDENDS OF \$905.58 PER MONTH PLUS INTEREST ON \$20,000 FROM MONEY MARKET FUNDS. THE CLIENT IS REQUESTING TO BE REIMBURSED FOR THE TOTAL AMOUNT OF PURCHASE OF THE PREFERRED STOCKS. CLAIMED LOSSES EXCEED \$5,000

FA RECOMMENDED THAT CLIENT LOOK AT ALTERNATIVE INVESTMENTS FOR THE PUTNAM FUNDS THAT HAD BEEN HELD FOR A LONG TIME BUT WERE SIGNIFICANTLY DOWN IN VALUE. FA SUGGESTED BOND FUNDS OR INDIVIDUAL BONDS, BUT CLIENT DESIRED TO INVEST IN PREFERRED STOCK. CLIENT GAVE LIST OF SEVERAL DIFFERENT PREFERRED STOCKS TO FA TO RESEARCH AND EVENTUALLY FA AND CLIENT CAME TO DECISION TO INVEST IN FANNIE MAE AND FREDDIE MAC PREFERRED SHARES. FA SUGGESTED CLIENT NOT INVEST ALL PROCEEDS INTO THESE TWO PREFERRED STOCKS, BUT CLIENT ASSURED FA THAT CLIENT HAD SIGNIFICANT HOLDINGS OUTSIDE OF FIRM THAT MADE THESE PURCHASES ONLY A SMALL PART OF HIS OVERALL PORTFOLIO. REVIEW OF CLIENT'S INVESTMENT OBJECTIVES AND REVELATION OF ASSETS OUTSIDE OF FIRM MADE PURCHASES NOT UNSUITABLE AT THE TIME THEY WERE MADE. UNFORTUNATELY, SUBSEQUENT EVENTS HAVE RESULTED IN DEVALUATION OF THESE PREFERRED STOCKS, BUT SUCH EVENTS OUTSIDE THE KNOWLEDGE OR CONTROL OF THE FA OR FIRM. DENIED CLIENT'S REQUEST FOR REIMBURSEMENT.
