IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - An "adjudicated" matter includes a disposition by (1) a court of law in a criminal or civil matter, or (2) an administrative panel in an action brought by a regulator that is contested by the party charged with some alleged wrongdoing.
 - A "settled" matter generally represents a disposition wherein the parties involved in a dispute reach an agreement to resolve the matter. Please note that Investment Adviser Representatives and firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Allegations: REGISTERED REPRESENTATIVE'S CUSTOMER/FRIEND ATTEMPTED TO WIRE MONEY INTO THE REGISTERED REPRESENTATIVE'S PERSONAL BANK ACCOUNT AS A ONE TIME LOAN. SECURITY RISK AND FRAUD DEPARTMENT FLAGGED THE WIRE AND BLOCKED IT. THEY CONTACTED THE CUSTOMER WHO CONFIRMED THAT THE WIRE WAS LEGITIMATE AND TOLD THE CUSTOMER THAT PURSUANT TO BANK POLICY THE WIRE CANNOT BE ACCEPTED INTO AN EMPLOYEE'S ACCOUNT. THE CUSTOMER THEN GAVE THE REGISTERED REPRESENTATIVE A CHECK IN LIEU OF THE WIRE AND THE REGISTERED REPRESENTATIVE DEPOSITED THE FUNDS INTO HIS PERSONAL ACCOUNT IN VIOLATION OF BANK POLICY. CONSEQUENTLY, THE REGISTERED REPRESENTATIVE WAS TERMINATED BY THE BANK.
