What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

MANY FOLLOW UP DISCUSSIONS/MEETINGS I AM NOT A PART OF AND CANNOT VERIFY THE QUESTIONS ASKED BY THE CLIENTS AND/OR ANSWERS GIVEN BY THE ADVISORS.

WITH THIS PARTICULAR CLIENT, I PRESENTED THE CPFA RETIREMENT ANALYSIS SHOWING THE PROBABILITY OF SUCCESS OF REACHING THEIR RETIREMENT GOALS IN BOTH THE CURRENT AND RECOMMENDED ASSET ALLOCATIONS. THERE WAS NO MENTION OF PRODUCT SOLUTION OR SPECIFIC ACTIONS TO BE TAKEN. THE CLIENT AGREED THAT IN THE CURRENT ALLOCATION, HE COULD BE LESS LIKELY OF REACHING HIS GOALS (USING MONTE CARLO ANALYSIS) UNDER HIS CURRENT PORTFOLIO ALLOCATION.

WE THEN BEGAN AN INITIAL DIALOGUE OF THE CHASE STRATEGIC PORTFOLIO (CSP). IN THAT DISCUSSION (AS IN ALL CSP PRESENTATIONS), THE FINANCIAL ADVISOR MENTIONED THAT THIS WAS A DISCRETIONARY PORTFOLIO. THE STATEMENT WAS MADE TO THE CLIENT THAT IN ALL NON-QUALIFIED ACCOUNTS, WHEN INITIAL FUNDS ARE MOVED INTO THE MANAGERS' DISCRETIONARY PORTFOLIO (AND SUBSEQUENT MOVES BY THE MANAGERS), BUYS AND SELLS COULD TAKE PLACE POTENTIALLY CREATING GAINS AND OR LOSSES; HOWEVER, SINCE WE ARE NOT TAX PROFESSIONALS, WE COULD NOT BE SPECIFIC ON THE PARTICULAR IMPACT THAT MIGHT HAVE IN THIS CASE. THIS IS WHERE MY ROLE ENDED.
