THE CLIENT ALLEGES THE FINANCIAL ADVISOR RECOMMENDED SHE WITHDRAW THE ENTIRE VALUE, AND REPOSITION INTO A NEW NON-QUALIFIED ANNUITY CONTRACT AND MUTUAL FUND POSITIONS WITHIN HER SINGLE ACCOUNT HELD WITHIN THE FIRM. SHE NOW HAS TAX CONSEQUENCES IN THE AMOUNT OF \$5,207. THE CLIENT FEELS THE FINANCIAL ADVISOR KNEW HE WAS LEAVING AND TOOK ADVANTAGE OF QUICK COMMISSIONS BY PROVIDING ADVICE THAT BEST SERVED HIS FINANCIAL BENEFIT, RATHER THAN HERS. THE CLIENT IS REQUESTING COMPENSATION FROM THE FIRM.
