IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: Based on findings of its internal review, firm alleges Mr. Scoular knowingly violated: (1) firm policies, procedures, and federal securities laws related to safekeeping of firm clients' nonpublic personal information and file materials by (a) on February 26, 2025, sending twenty emails with attached compilations of at least ten firm clients' nonpublic personal information ("NPPI") to his non-firmaffiliated assistant on outside business activities, and (b) upon his April 4, 2025 departure from firm, retaining without authorization non-"scrubbed" laptop containing firm clients' NPPI and file materials; and (2) firm policies, procedures, and federal securities laws by failing to maintain necessary and appropriate books and records as to at least 26 firm clients.
