**Allegations:** The client alleged that her portfolio was mismanaged by her advisor, causing it to underperform. The client also alleged that her assets have been placed into funds with high expense ratios, that her accounts were rebalanced in a manner which will cause her tax issues to correct and her portfolio has been out of alignment with her requested aggressive investment strategy.

**Broker Statement**

The firm's review found no evidence to support the client's allegations or any indication of wrongdoing by the advisor. It was determined that the client's investments were aligned with the client's aggressive risk tolerance, time horizon, and investment objectives for each of the client's accounts. It was determined that the majority of the client's holdings were Exchange Traded Funds (ETFs) with low expense ratios and that the client also requested holdings that met Socially Responsible Investing (SRI) and/or Environmental, Social, and Governance (ESG) criteria, which had higher expense ratios than other comparable holdings in her portfolio. It was also determined that the client's investment rate of return was in line with the expected returns for the type of allocation that the client maintained over the time period in question. Lastly, any tax consequences were a result of the client voluntarily choosing to liquidate highly appreciated assets, further illustrating the significant growth in the client's investment principal while under the advisor's management.
