IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: 9/9/10-4/11; THE CLIENT STATES THAT THE FA EXPLAINED THAT THEY WERE PURCHASING A MUNICIPAL INCOME TRUST FUND WHICH WOULD BE INSURED FOR THE FULL PRINCIPLE IF THEY WOULD AGREE TO TAKE 1% LESS IN INTEREST; THEY STATE AT THE TIME OF THE INVESTMENT THE INTEREST WAS 4.3%. THEY STATE THEY WERE NOT PROVIDED AN INVENTORY OF THE INVESTMENTS. THEY ALSO STATE THEY WERE NOT INFORMED THE MATURITY WOULD OUTLIVE THEIR LIFE EXPECTANCIES. THEY INDICATE THE PRINCIPLE WAS INSURED BUT THE VALUE OF THE INVESTMENTS DECLINED.

Broker Statement

THE FA MET WITH THE CLIENT AND HER HUSBAND TO REVIEW SEVERAL INVESTMENT OPTIONS. THE CLIENT INFORMED THE FA THAT SHE WAS INTERESTED IN INSURED TAX FREE BONDS. IT WAS EXPLAINED TO THE CLIENT THAT THE RATE WAS LOWER ON THE INSURED INVESTMENTS. THE CLIENT WANTED TO GENERATE INCOME FROM THE PROCEEDS OF SELLING A HOME. THE CLIENT DID NOT INFORM THE FA THAT SHE WOULD CONSIDER PURCHASING A NEW HOME IN LESS THAN A YEAR; THE FA STATES HE WAS INFORMED BY THE CLIENT AND HER HUSBAND THEY WERE NOT INTERESTED IN PURCHASING A NEW HOME. THE FA STATES THE INSURANCE ON THE INVESTMENTS WAS ON THE INDIVIDUAL BONDS WITHIN THE INVESTMENT; THE BONDS WITHIN THE INVESTMENTS ARE INSURED IF A BOND DEFAULTS. THE CLIENT AND HER HUSBAND WERE INFORMED THE VALUE OF THE INVESTMENTS COULD FLUCTUATE DUE TO MARKET CONDITION. THE INVESTMENTS CAN BE LIQUIDATED AT ANY TIME DURING MARKET HOURS, BUT THE PRICE IS SUBJECT TO CURRENT MARKET CONDITIONS. THE CLIENT SIGNED A BUY ACKNOWLEDGEMENT LETTER AT THE TIME OF PURCHASE. THE LETTER INDICATED THE CLIENT WAS AWARE OF THE RISKS, COMMISSION, FEES AND THAT THE VALUE COULD FLUCTUATE. THE CLIENT WAS ALSO PROVIDED WITH CONFIRMATIONS AND PROSPECTUS FOR EACH TRANSACTION. THE CLIENT'S REQUEST FOR REIMBURSEMENT IS RESPECTFULLY DENIED. AMENDED CONCLUSION: FOR BUSINESS REASONS AND TO AVOID LITIGATION, THE FIRM SETTLED THE MATTER WITH THE CLIENT FOR \$14,000.
