What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: 11/07-7/27/09; THE CLIENT STATES THAT HER FINANCIAL ADVISOR IN NOVEMBER 2007 WAS TOLD THAT SHE WANTED AN ANNUITY WITH A GUARANTEE OF NO LOSS. THE CLIENT STATES THAT SHE HAS SINCE LEARNED MORE THAN SHE KNEW AT THAT TIME AND FEELS THAT THE FINANCIAL ADVISOR WAS NOT TAKING INTO CONSIDERATION THAT THE \$90,000 WAS ALL SHE HAD EXCEPT HER HOME, RETIREMENT AND SOCIAL SECURITY. THE CLIENT CLAIMS SHE WAS PUT INTO VERY AGGRESSIVE INVESTMENTS AND LOST A GREAT DEAL OF MONEY. THE CLIENT STATES THERE IS \$47,086 LEFT OF THE \$90,000 MINUS \$8,325 TAKEN IN WITHDRAWALS WITH MEANS A LOSS OF \$34,602. THE CLIENT WANTS TO KNOW WHAT TO DO TO RECOUP THE LOSS.

IT WAS EXPLAINED TO THE CLIENT THAT HAD SHE EXPRESSED CONCERN WITH THE FINANCIAL ADVISOR'S RECOMMENDATIONS AT THE TIME OF PURCHASE, HE WOULD HAVE DISCUSSED ADDITIONAL OPTIONS. NO ADJUSTMENT WILL BE MADE AT THIS TIME.
