What is included in a IAPD report?

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and

Regulator Statement n February 28, 2023, the Office of Financial Regulation (Office) entered a Final Order adopting the Stipulation and Consent Agreement in the matter of Jason P. Kelso (Kelso). Kelso neither admitted nor denied the allegations but consented to the entry of findings by the Office. The Office found that Kelso violated Section 517.12(4), Florida Statutes, by rendering investment advice, from a location within Florida, without being registered by the Office. Kelso agreed to Cease and Desist from violations of Chapter 517, Florida Statutes, and the Administrative Rules adopted thereto, and to pay an administrative fine in the amount of \$6,500. The Office agreed to approve Kelso's application as an associated person (RA) with Merrill Lynch, Pierce, Fenner & Smith Incorporated effective February 28, 2023.
