What is included in a IAPD report?

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

THE FUNDS WERE IN A TRUST AND THE CLIENT WAS THE TRUSTEE FOR HIS 85 YEAR OLD MOTHER'S ACCOUNT. THE ACCOUNT WAS OPENED IN OCTOBER 2007 AND TRANSFERRED IN OCTOBER 2008. DEMAND FOR DAMAGES IS \$200,000.

Broker Statement

THE FIRM'S REVIEW REVEALED THAT THE ACCOUNT WAS INVESTED IN ACCORDANCE WITH THE CLIENT'S STATED INVESTMENT OBJECTIVES AND THAT ALL PAPERWORK WAS PROPERLY SIGNED. THE DAMAGES CLAIMED TO BE \$200,000 WERE OVERSTATED. ACTUAL LOSS WAS \$57,000 WHICH WAS SIGNIFICANTLY BETTER PERFORMANCE THAN THE OVERALL MARKET DURING THE SAME TIME PERIOD. THE CLAIM WAS DENIED IN ITS ENTIRETY.

CLIENT CLAIMED THE FUNDS WERE GOING TO BE HIS WITH A MILD POSSIBILITY THAT HE MIGHT USE IT FOR HIS MOTHER'S NURSING HOME. CLIENT HAD POA ON THE ACCOUNT AND INDICATED HIS RISK TOLERANCE WAS A "MODERATE GROWTH AND INCOME". INITIATING FINANCIAL ADVISOR THAT PUT THE ALLOCATION TOGETHER USED THE FIRMS FUNDS WITHIN THE "CUSTOM CHOICE" ACCOUNT THAT WERE MEANT TO MIRROR LEVEL OF RISK. CLIENT INVESTED FUNDS BACK AT THE HEIGHT OF THE MARKET AND THE LOSS WAS DUE TO MARKET LOSSES.
