What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

I had requested a personal banker to transfer funds from a clients savings account into her checking account, which the client had authorized, to fund a mutual fund trade in her brokerage account, which was linked to her checking account at Chase Bank. Since the Personal Banker did not want to make a mistake and inconvenience my client by transferring funds from the wrong account, he asked and authorized me to review the accuracy of the transaction, fill in the transfer amount of \$45K and ascertain the accuracy of the information. After which point he left his cubicle and returned, at which point I had key punched the transfer to facilitate the availability of funds for the mutual fund trade my client had requested me to place in her brokerage account and provided both client and personal banker a hard copy of the same.
