### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Allegations:** CLIENT STATES THAT IN 2010 THE FINANCIAL ADVISOR RECOMMENDED LIQUIDATING \$50,000 OF HIS ANNUITY AND MOVING IT TO HIS INDIVIDUAL ACCOUNT. LATER THAT YEAR, IN AUGUST, THEY MOVED ANOTHER \$50,000 AND THE CLIENT WAS ABLE TO WITHDRAW \$500 PER MONTH. THE CLIENT RECEIVED AN IRS NOTIFICATION IN 2012 THAT INDICATED HE OWED TAXES AND PENALTIES TOTALING \$23,666 BASED ON THE TAXABLE AMOUNT OF \$81,133.87 FROM THE ANNUITY LIQUIDATIONS IN 2010. THE CLIENT THINKS THE FIRM SHOULD COMPENSATE HIM FOR THIS COSTLY MISTAKE.

DENIED. IT IS OUR UNDERSTANDING THE CLIENT WAS INFORMED OF TAX IMPLICATIONS RELATED TO THE HARTFORD ANNUITY WITHDRAWALS. IN MARCH 2010 THE FINANCIAL ADVISOR RECOMMENDED THE CLIENT SPEAK WITH HIS TAX PROFESSIONAL REGARDING POSSIBLE TAX LIABILITY ASSOCIATED WITH ANNUITY LIQUIDATIONS WHEN HE RECOMMENDED REPOSITIONING TO REDUCE VOLATILITY AND PRODUCE INCOME. HARTFORD ISSUED A 1099-R TO THE CLIENT IN EARLY 2011, DOCUMENTING A \$100,000.00 GROSS DISTRIBUTION IN BOX 1, AND A TAXABLE AMOUNT OF \$81,337.87 IN BOX 2A. THIS DOCUMENT WAS ALSO PROVIDED TO THE INTERNAL REVENUE SERVICE TO REPORT TAXABLE TRANSACTIONS ON THE CLIENT'S BEHALF. FIRM ASSOCIATES ARE NOT TAX ADVISORS, AND THEREFORE, DO NOT PROVIDE ADVICE. IT IS OUR UNDERSTANDING THE CLIENT REVIEWED THE 1099-R WITH HIS TAX PROFESSIONAL IN PREPARATION OF THE 2010 TAX FILING, BUT ELECTED NOT TO INCLUDE THE VALUE IN HIS RETURN.

UPON FURTHER REVIEW, THE CLIENT'S CLAIM WAS RESOLVED IN THE AMOUNT OF \$8,054.24. THE FINANCIAL ADVISOR WAS NOT REQUIRED TO CONTRIBUTE TO THE RESOLUTION.
