IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Customer Dispute

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. Reporting Source: Individual

Employing firm when activities occurred which led to the complaint: Verus Financial Partners

Allegations: The client's complaint alleged that certain advice given by Edward ("Ed") L. Hoppe, III was inappropriate for the client's circumstances. The complaint requested \$260,000 in damages. A formal civil matter was not filed, but the dispute proceeded to mediation. Rather than incur the mental and monetary costs of further defense Ed Hoppe and the firm elected to settle the matter in the amount of \$160,000 on October 11, 2022. Notwithstanding the settlement, Ed Hoppe and the firm continue to adamantly believe that they met all professional obligations to the client, and that, to the extent, any harm to the client arose, such harm is more directly attributable to the custodian's refusal to distribute IRA assets in a manner requested by Ed Hoppe and the firm, as well as the client's refusal to seek independent legal counsel around the issue, despite Mr. Hoppe's and the firm's consistent recommendations to do so.
