IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: THE DECEASED CLIENT'S SPOUSE INDICATES THE FINANCIAL ADVISOR INSISTED THE CLIENT COMPLETE A TRANSFER ON DEATH (TOD) FOR HIS ACCOUNT IN JULY 2009. HAVING JUST COMPLETED A WILL WITH THE ATTORNEY, THE SPOUSE STATES THE TOD WAS TO BE 70% OF THE ACCOUNT TO HER, AND 30% TO 15 EXTENDED FAMILY MEMBERS. THE SPOUSE STATES IT WAS HER AND HER HUSBAND'S UNDERSTANDING THAT THE TOD WAS THE SAME AS THE WILL, AND THAT AT HIS DEATH, THE ACCOUNT WOULD BE AVAILABLE FOR FUNERAL EXPENSES. THE CLIENT PASSED AWAY IN JANUARY 2012, AND THE SPOUSE HAS FOUND THAT THE TOD LISTS ONLY THE 15 FAMILY MEMBERS, AND THE ACCOUNT HAS BEEN RESTRICTED. SHE ALLEGES THIS WAS THE FINANCIAL ADVISORS OVERSIGHT AND SHE WANTS THE TOD CORRECTED TO MATCH THE WILL AS THE CLIENT HAD WISHED.
