What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement MORGAN STANLEY SMITH BARNEY ALLEGES THAT IT TERMINATED MY EMPLOYMENT DUE TO CONCERNS REGARDING THE POSSIBLE SOLICITATION OF AN UNREGISTERED BOND IN VIOLATION OF STATE BLUE SKY LAWS. FIRST, I VEHEMENTLY DENY THE ALLEGATIONS THAT I SOLICITED THE SALE OF ANY SUCH BOND. THE SALE OF THE BOND IN QUESTION WAS UNSOLICITED. I HAD PROVIDED A COPY TO MORGAN STANLEY SMITH BARNEY DURING THEIR INVESTIGATION, LETTERS FROM EACH OF MY CLIENTS STATING THEY WANTED TO PURCHASE THE BOND. THERE WAS NO EVIDENCE THAT I SOLICITED THE SALE OF THE BOND AT



ISSUE IN VIOLATION OF THE STATE BLUE SKY LAWS. MOREOVER, A MALE COLLEAGUE OF MINE AT MORGAN STANLEY SMITH BARNEY SOLICITED THE SALE OF THE SAME BOND THAT WAS AT ISSUE; HOWEVER THAT INDIVIDUAL WAS NOT INVESTIGATED, DISCIPLINED NOR TERMINATED. PRIOR TO MY TERMINATION, I HAVE NEVER BEEN DISCIPLINED IN ANYWAY DURING MY 6 YEAR EMPLOYMENT AT MORGAN STANLEY SMITH BARNEY. IN SUM, MORGAN STANLEY SMITH BARNEY HAS KNOWINGLY REPORTED UNSUBSTANTIATED ALLEGATIONS AGAINST ME AND FALSELY REPORTED IT'S MOTIVATION FOR TERMINATING ME.
