IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Buerger Insurance Solutions is a dba of ALTUS, Inc and was started in 2013 although John has maintained his California Life Insurance license since 2004. The company's address is 15550 Abierto Rd, Atascadero, CA 93422. Typically, less than 2 hours each month is devoted to this business or operations.

John Buerger is the business manager for Accents, a retail business in Atascadero. He is also a 50% owner (through the ALTUS Inc corporation which operates Accents as a dba) of the company. The business was originally purchased in March, 1993 as a sole proprietorship. John is responsible for maintaining business systems, monitoring financials and helping out as needed in off-hours (weekends and evenings). An average month requires 10-12 hours of his time to devote to these duties.

Broker Statement Since WealthWise was leaving Associated Securities and going independent, the firm principal had told me that taking the Series 7 was not necessary and that my CFP would qualify me (which it does as a Registered Rep of an RIA). I was told by my superiors to focus on my duties with the firm at the time (business systems and writing financial plans for the firm's clients). Had I known that this was going to be an issue, I would have taken the exam and/or fulfilled any other requirements



dictated by Associated Securities.
