IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: THE CLIENT STATES THAT THE FINANCIAL ADVISOR MISREPRESENTED A TRANSACTION WHEREBY FUNDS WERE TAKEN OUT OF HIS IRA AND THAT THE ACTIONS WOULD RESULT IN A SUBSTANTIAL TAX CONSEQUENCE. THE CLIENT STATES HE HAS NEVER PUT HIMSELF IN A POSITION WHERE HE WOULD OWE TAXES OR PENALTIES. THE CLIENT STATED THE FINANCIAL ADVISOR PLACED THE FUNDS IN A ROTH IRA BUT DID NOT MARK ANY TYPE OF WITHDRAWAL ON THE FORM THAT THE CLIENT SIGNED. THE CLIENT STATED THAT THE FINANCIAL ADVISOR DID NOT INDICATE HE WAS CLOSING THE IRA, ONLY MOVING MONEY TO OTHER INVESTMENTS. THE CLIENT STATES HE DID NOT GIVE PERMISSION TO TRANSFER MONEY IN OR OUT OF THE ROTH IRA. THE CLIENT STATES THIS WAS COMPLETELY MISREPRESENTED TO HIM. FILING REQUIRED. TAXES AND PENALTIES OWED AS A RESULT IN EXCESS OF \$5,611.00.

Broker Statement IT WAS DETERMINED THAT IN MAY 2008 FUNDS WERE TRANSFERRED INTO EDWARD JONES AND CODED TO BE PLACED IN THE CLIENT'S ROTH IRA. SHORTLY AFTER, THE CLIENT REQUESTED THE FUNDS BE TRANSFERRED FROM THE ROTH IRA TO HIS SINGLE ACCOUNT, RESULTING IN A TAXABLE EVENT. ALTHOUGH THE TRANSACTIONS AND TRANSFERS WERE AUTHORIZED BY THE CLIENT AND COMPLETED AT THE CLIENT'S REQUEST, EDWARD JONES OFFERED TO CREDIT THE CLIENT'S ACCOUNT IN THE AMOUNT OF \$10,000. THE OFFER WAS ACCEPTED THROUGH CORRESPONDENCE FROM THE



CLIENT'S ATTORNEY DATED 12/13/10.
