IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

POSITION: Landowner NATURE: We purchased land in Delton, MI in 2008. The 100 acres is primarily recreational property. In 2011 we had one contract to sell timber, generating approximately \$3500 in net income. This is on an 'as needed' basis, with no current plans to market timber. In 2013, we entered into a 5 year mineral lease agreement with West Bay Exploration of Traverse City, MI. The contract paid a \$7500 signing bonus, but has not moved forward with any exploration or drilling. There is an option to renew after 5 years at the same bonus rate. In 2015, an existing billboard contract lapsed, causing a new contract to begin with CBS outdoor. The contract pays approximately \$900 per year to keep a billboard on part of the road frontage. This is a twenty year contract. INVESTMENT RELATED: No NUMBER OF HOURS: 1 SECURITIES TRADING HOURS: 0 START DATE: 05/15/2008

DESCRIPTION: Outside of the time that has spent negotiating the three contracts, there has been no need for ongoing work (passive income). Other activities associated with the land (hunting, camping, hiking, etc) are of a purely recreational nature.
