What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

THE FA INDICATED THE CLIENT'S ACCOUNTS WERE DIVERSIFIED AND DID NOT RECOMMEND CHANGES. HE STATED HE DID PRESENT A BOND, BUT THE CLIENT WAS NOT HAPPY WITH THE RATE. ACCORDING TO THE FA, HE INFORMED THE CLIENT THAT MOST ASSETS, EXCEPT FOR CASH AND CDS, WERE LOSING VALUE. THE FA HAS STATED THE CLIENT WAS NOT HAPPY WITH THE ANNUITY AND REPEATEDLY INFORMED HIM SHE DID NOT WANT TO BE INVESTED IN THE ANNUITY. ACCORDING TO THE FA, HE INFORMED THE CLIENT THAT SHE COULD LIQUIDATE WHILE THE MARKET WAS LOW AND SPREAD OUT THE TAXES. THE FA INDICATES THE CLIENT APPROVED THE LIQUIDATION AND PURCHASE OF AMERICAN FUNDS. THE ASSETS IN THE SINGLE AND RETIREMENT ACCOUNTS APPEAR TO HAVE BEEN WITHIN THE SCOPE OF THE INVESTMENT OBJECTIVES. WHILE WE UNDERSTAND THE CLIENT'S DISAPPOINTMENT WITH THE PERFORMANCE OF THE INVESTMENTS, THE PERFORMANCE IS ATTRIBUTED TO CIRCUMSTANCES BEYOND OUR CONTROL AND MARKET FLUCTUATION, WHICH IS A RISK ASSOCIATED WITH INVESTING. IN LIGHT OF THESE CIRCUMSTANCES THE CLIENT'S REQUEST FOR REIMBURSEMENT IS RESPECTFULLY DENIED.
