IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Customer Dispute

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. Reporting Source: Individual

Employing firm when activities occurred which led to the complaint: Wealth Navigation

Allegations: Consistent with its supervisory and fiduciary duty under the Investment Advisers Act of 1940 ("1940 Act"), the firm self-reported detection of certain investment adviser representative ("representative") conduct which was believed to be in violation of various provisions of the 1940 Act. Along with immediate termination of that representative from Wealth Navigation for failure to disclose outside business activities ("OBA"), the United States Securities & Exchange Commission ("SEC") investigated the firm's self-report and determined that the report was meritorious. In fact, the firm was the first to detect the OBA which had gone undetected by multiple firms through which the individual had been previously licensed for what the SEC believes was roughly 15 years. In 2022, associated with the violative conduct reported by WN, an AAA arbitration claim was filed against tangentially related parties, including WN, Jones and Fisher, for alleged failure to supervise and other similar claims regarding the representative's conduct which WN had self-reported. The representative did not participate in the SEC's investigation nor in the AAA claim because he was deceased by that time. The result of the AAA arbitration claim was dismissal with prejudice with damages of \$700,000 awarded to claimants in 2023 by WN.
