IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

HIS MOVE TO WEST VIRGINIA; HOWEVER AT NO TIME DID CLIENT COMMUNICATE TO HIM THAT THIS MONEY SHOULD REMAIN IN CASH. FA INDICATED HE ULTIMATELY RECOMMENDED A PORTFOLIO OF STOCKS AND BONDS AND AFTER THE SPECIFIC INVESTMENTS WERE REVIEWED, THE CLIENT AUTHORIZED THE TRANSACTIONS. FA STATED HE SPOKE WITH CLIENT ON SUBSEQUENT OCCASIONS TO DISCUSS THE CLIENT'S ACCOUNTS AND AT NO TIME DID HE BLAME THE FA FOR THE LOSSES (ON PAPER) IN HIS ACCOUNTS. FA HAS INDICATED CLIENT IS A PRACTICING CPA AND HAS ALSO BEEN A REGISTERED INVESTMENT ADVISOR IN THE PAST AND, THEREFORE, THE CLIENT HAS AN UNDERSTANDING OF HOW THE MARKETS WORK. WHILE WE CERTAINLY UNDERSTAND CLIENT'S DISAPPOINTMENT IN THE DECLINE IN VALUE OF THE INVESTMENTS HELD IN HIS ACCOUNTS, WE HAVE BEEN EXPERIENCING TUMULTUOUS MARKET CONDITIONS AND FLUCTUATION IS A RISK ASSOCIATED WITH INVESTING. FA HAS FIRMLY STATED AT NO TIME DID HE EXERCISE DISCRETION IN THE CLIENT'S ACCOUNTS. FURTHER, AT THE TIME OF THE TRANSACTIONS IN AUGUST 2008, TRADE CONFIRMATIONS WOULD HAVE BEEN MAILED TO THE CLIENT'S ADDRESS OF RECORD AND HE WOULD HAVE BEEN IN RECEIPT OF ACCOUNT STATEMENTS, WHICH REFLECT ALL ACCOUNT ACTIVITY. LASTLY, FA HAS PROVIDED ME WITH A COUPLE OF PERSONAL EMAILS (BETWEEN THE FA AND CLIENT) AND IT DOES NOT APPEAR CLIENT HAD ANY CONCERNS RELATING TO THE ACTIVITY IN HIS ACCOUNTS. BASED ON OUR REVIEW, WE RESPECTFULLY DENY THE REQUEST TO REINSTATE HIS ACCOUNTS TO THE ORIGINAL VALUES TRANSFERRED TO OUR FIRM.
