What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Regulator Statement

On December 16, 2022, the Office of Financial Regulation (Office) entered a Final Order adopting the Stipulation and Consent Agreement in the matter of Marc Lee Russell (Russell). Russell neither admitted nor denied the allegations but consented to the entry of findings by the Office. The Office found that Russell violated Section 517.12(4), Florida Statutes, by rendering investment advice, from a location within Florida, without being registered by the Office. Russell agreed to Cease and Desist from violations of Chapter 517, Florida Statutes, and the Administrative Rules adopted thereto, and to pay an administrative fine in the amount of \$6,875. The Office agreed to approve Russell's application as an associated person (RA) with Mariner Wealth Advisors effective December 16, 2022.

Broker Statement

As a result of an administrative error by a compliance consultant utilized by Marc Russell's (Mr. Russell) former employer, Mr. Russell was not timely registered with the Florida Office of Financial Regulation ("Office") as an investment adviser representative (IAR) upon the commencement of his relocation to Florida in December 2020. Mr. Russell timely notified his prior employer of his relocation to the State of Florida and relied on his prior employer's compliance consultant to complete and maintain the proper registrations relating to his employment duties. The consultant inadvertently failed to file the necessary paperwork for Mr. Russell's IAR registration in the State of Florida. On 12/16/2022, the Office issued a final order finding that Mr. Russell engaged in investment advisory business in offices within Florida without the benefit of lawful registration in Florida, pursuant to section 517. 12(4) of the Florida Statutes. Without admitting or denying the findings, Mr. Russell accepted the findings and agreed to cease and desist from all present and future violations of Chapter 517, Florida Statutes and the rules thereunder. The Office agreed to approve Mr. Russell's application as an associated person with MWA, effective 12/16/2022.
