IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement 1) time and price discretion



I liquidated a clients' large penny stock position over several months, with the clients' full approval and permission.

Management determined in retrospect that trades executed above the clients' target price, without her specific approval, amounted to me exercising unauthorized discretion.

2) I hand-carried client deposit checks to the branch office on multiple occasions for over a year, with full knowledge of the head cashier and branch management. In retrospect branch management determined this was a violation of policy.

3) The branch compliance manager ordered me to alter my answer on a FINRA questionnaire, to admit to a client complaint.

This was despite the fact that the clients' complaint was about branch operations, unrelated to any of my actions, and that the same manager had informed me earlier that the clients' concerns had been addressed and that there was no complaint against me.
