**Allegations:** COMPLAINANT ALLEDGES MR. MAZUR ADVISED HER TO WITHDRAW \$120,000 FROM HER IRA ACCOUNT AND DEPOSIT THE FUNDS INTO HER THRIFT SAVINGS PLAN (TSP) AND THEN TO WITHDRAW THE FUNDS FROM THE TSP AND DEPOSIT THEM INTO AN IRA ACCOUNT AND THEN TO ROLL THOSE FUNDS INTO A IRA ROTH ACCOUNT. DURING THE COURSE OF TRANSACTIONS, MAZUR ALLEGEDLY ACCEPTED AND DEPOSTIED A \$70,00 OVERPAYMENT. THE SERIES OF TRANSACTIONS RESULTED IN \$191,596 IN TAXABLE RETIREMENT INCOME AND COMPLAINANT WAS REQUIRED TO PAY THE IRS \$65,246 IN TAXES, NEGLIGENCE PENALTY AND INTEREST.

THE COMPLAINT WAS FILED OUT OF CONFUSION RATHER THAN ERROR. THE PURPOSE OF THE TRANSACTION WAS TO TAKE ADVANTAGE OF A UNIQUE BENEFIT AVAILABLE TO ONLY FEDERAL EMPLOYEES PART OF THE OLD RETIREMENT SYSTEM. THE FUNDS USED IN THE TRANSACTION WERE POST-TAX DOLLARS ORIGINATING FROM A NON-QUALIFIED ACCOUNT. [CUSTOMER] LEFT LUKE FINANCIAL IN THE MIDDLE OF THIS PROCESS AND BEGAN WORKING WITH AN ADVISOR THAT IS NOT FAMILIAR WITH FEDERAL BENEFITS. JONATHAN MAZUR IMMEDIATELY REACHED OUT TO [CUSTOMER] UPON RECEIPT OF THIS COMPLAINT. ALL DOCUMENTATION OF THESE TRANSACTIONS HAVE BEEN PROVIDED AND WE ARE CLOSELY WORKING WITH [CUSTOMER] AND HER CPA TO RESOLVE THE MATTER. [CUSTOMER] SPOKE TO MR. MAZUR AS HAS WRITTEN A RETRACTION LETTER STATING SHE DID RECIEVE A FULL REFUND FROM THE IRS DUE TO THE ASSISTANCE AND HELP FROM MR. JONATHAN MAZUR.
