Broker Statement

Trent indicates that the client contacted him shortly after Apple announced a stock split and requested that he buy to close covered calls that were now in-the-money. Trent told the client that this contradicted her confirmed strategy of having shares assigned in order to reduce a concentrated position. Additionally, Trent disclaimed that this action would result in a loss and the orders were being placed solely based on the client's request. No action was taken on this claim.
