Broker Statement

Mr. Yoakley was an investor and director for Ionogen from 2018 until February 2023. Ionogen was a start-up aimed at developing a "green" disinfectant. Started just before the pandemic, Ionogen saw its sales grow significantly when the company pivoted during Covid-19 to address the residential demand for disinfectants that were proven to be more effective against Covid-19. As the pandemic waned and disinfectant use decreased dramatically, Ionogen's sales suffered. Unable to support the staff required during the pandemic amid low sales, Ionogen made drastic cost cuts and workforce reductions. The Company's



directors sought venture capital partners or other business acquisition options to find a path forward for Ionogen. However, with the company struggling to meet its obligations, all of the company directors resigned except Mr. Yoakley and one other director. Left to resolve Ionogen's fate alone, Mr. Yoakley and the other remaining director had no choice but to file for bankruptcy in February 2023. Mr. Yoakley was an independent director - not an employee of Ionogen - and never received a salary or compensation related to his activities.
