IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Client alleges that the recommendation to transfer of assets into a new managed account in 2016, and the subsequent sales of those assets within the account resulted in her incurring unexpected taxable gains. Client is requesting to recoup the capital gains tax she was required to pay.

Allegations: Client claims in a letter on May 5, 2017 that the representative's recommendation in 2016 to transfer assets into a professionally managed portfolio caused her to incur taxable gains from the sale of those assets that limited tax benefits she otherwise would have received from an unrelated investment activity. Subsequently, the client has asked for compensation to cover the amount of additional taxes she incurred. The client also complains that the TIAA managed portfolio purchased high risk international stocks despite the client's moderate risk tolerance.
