What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: 10/10-12/15/10; THE CLIENT CLAIMS THAT SHE HAD \$90,000 FROM AN INHERITANCE AND WANTED TO INVEST THE FUNDS SHORT TERM AS SHE WAS GOING TO NEED THE FUNDS TO BID IN A HOUSE AUCTION IN MID OCTOBER 2010. THE AUCTION WAS DELAYED UNTIL 1/13/2011 AND CLAIMS THE FINANCIAL ADVISOR ASSURED THAT HE COULD INVEST THE MONEY AND MAKE AS MUCH AS FIVE PERCENT COMPARED TO THE ONE PERCENT IF LEFT IN THE BANK. THE CLIENT STATES IN LESS THAN EIGHT WEEKS THE INVESTMENT LOST A LITTLE OVER \$8,000. THE CLIENT CLAIMS SHE DID NOT KNOW WHAT THE CHARGES WERE TO PURCHASE THE INVESTMENT AND STATES SHE LEARNED THAT PIMCO WAS A LONG TERM, HIGH-RISK INVESTMENT. THE CLIENT STATES SHE WAS NOT INFORMED OF THE LONG TERM, HIGH RISK NATURE OF THE INVESTMENT AND REQUESTS THAT EDWARD JONES REIMBURSE HER FOR LOSSES AND FEES PAID. THE CLIENT STATES WHILE SHE DID SIGN AN "AFFIDAVIT" THAT THERE WAS SOME RISK INVOLVED AND THERE WOULD BE A FEE, THE FEE AMOUNT WAS NOT STATED IN THE DOCUMENT OR EXPLAINED VERBALLY.
