suspect the client may have been confused by the e-signature as it does not look like a handwritten signature. In any event, I did not sign or e-sign the document on behalf of the client. LPL reviewed the complaint and determined that the application was sent to the client for e-signature via her email account of record, to which I have no access. In denying the complaint, LPL also reviewed the fact that the client's e-signature was provided via a different IP address from my own, which is consistent with the fact that the client and I do not reside in the same geographic area. It is unfortunate that this client made an unfounded and untrue allegation before understanding the facts.

**Broker Statement**

THE ARITRATION WAS SETTLED BY RESPONDENT LPL, MY BROKER-DEALER, FOR \$2,750. I DID NOT PAY ANY AMOUNT TOWARD THE SETTLEMENT. BOTH LPL AND I DENIED AND CONTINUE TO DENY ANY WRONGDOING WHATSOEVER. LPL'S DECISION TO SETTLE THIS CASE FOR NUISANCE VALUE WAS DRIVEN BY THE FACT DEFENDING THE CASE WOULD COST CONSIDERABLY MORE THAN THIS SMALL AMOUNT.

THE ARBITRATION WAS FILED BY A FORMER FINANCIAL ADVISOR ON BEHALF OF HIS WIFE, THE CLAIMANT. THE CLAIMANT'S HUSBAND HAD BEEN A FINANCIAL ADVISOR FOR 15 YEARS, INCLUDING SEVERAL YEARS AT LPL IMMEDIATELY PRECEEDING HIS RETIREMENT. PRIOR TO RETIRING, THE FORMER FINANCIAL ADVISOR PLACED HIS WIFE'S ACCOUNT IN THE INVESTMENT PROGRAM AT ISSUE WITH THE UNDERSTANDING THAT THERE WERE LIMITS IN KEEPING ANY FUNDS THEREIN IN CASH. IT REMAINED THERE FOR SEVERAL YEARS, UP UNTIL THE EARLY PART OF THE COVID CRISIS WHEN THE FORMER FINANCIAL ADVISOR DETERMINED TO MOVE HIS WIFE'S ACCOUNT TO 100% CASH, AND WAS INFORMED AND UNDERSTOOD THERE WERE TIME LIMITS ON KEEPING IT IN CASH. THE ALLEGED LOSS OCCURRED WHEN THE CLAIMANT CHOSE TO LIQUIDATE THE ACCOUNT A FEW DAYS AFTER IT HAD GONE DOWN IN VALUE FOLLOWING THE AUTOMATIC REALLOCATION TO THE MARKET (AS PER RULES GOVERNING THE ACCOUNT). I ADVISED THE CLAIMANT AND HER HUSBAND AGAINST LIQUIDATING AND SUGGESTED SHE REMAIN IN THE MARKET. HAD MY ADVICE BEEN FOLLOWED, THE ACCOUNT WOULD HAVE REALIZED A SUBSTANTIAL GAIN AS OF DECEMBER 1, 2020.
