What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

I met with this client just one time and for only about an hour. He was already a client of the Firm and had been working with another advisor. At the time I spoke to him, he already owned the Ultra Short Bond Fund. The client was provided a prospectus of the fund, which explained the inherent risks associated as well as having the risks explained by the other advisor. I told him that the fund's value could be affected by interest rate changes, but because the bonds were much shorter in maturity than a year, were less likely to be affected. The client told me to place the remainder of his money in this fund, which I did. At a later date, he instructed my partner, via a phone call, to sell it all. The sell order was placed, but due to a documentation error, the sale commission was not reduced. When this error was noticed the next morning, unfortunately, due to the increased back office activity due to the pandemic, it took three days to reverse the commission. In a normal daily activity before COVID, this would probably have been corrected within one day and not shown up as an additional loss in the client's account, which the client, in his complaint, lumped into one stated loss amount. As a result, client's losses would have been under the FINRA reporting threshold of \$5,000 and thus would probably not have resulted in this filing. This is the first FINRA complaint I have had in my 14 years in the securities business.
