OF THEIR OWN ACCORD THEY SURRENDERED THE ANNUITIES, THEN BROUGHT IN PERSONAL CHECKS TO BE DEPOSITED INTO THEIR ACCOUNTS. UPON THE DEPOSIT WE PROCEEDED WITH PURCHASING SOME HIGHLY RATED PRODUCTS TO HELP THEM WITH THEIR CURRENT NEEDS. IT IS ALLEGED THAT I TOLD THEM TO SURRENDER THE OLD CONTRACTS EVEN WITH THE PENALTY INVOLVED. THE FACT THERE WAS A SURRENDER MADE ME DO THE OPPOSITE. THE DECISION TO PROCEED WAS SOMETHING DONE OF THEIR OWN ACCORD. IT WAS DIFFICULT TO FORSEE THE RESULT TWO YEARS COMING ALONG FROM HELPIN A CLIENT DO EXACTLY WHAT WAS REQUESTED, AND ULTIMATELY RESULT IN AN A MARK ON MY LICENSE AND POTENTIAL FINANCIAL PENALTY.
