### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Broker Statement**

THE FA ADVISED THAT THE CLIENT TRANSFERRED HIS IRA ACCOUNT INTO THE BRANCH OFFICE WITH THE INTENT OF REALLOCATING HIS PORTFOLIO. SINCE HE WAS INTERESTED IN INCOME, THE FA REVIEWED OUR FIRM'S RECOMMENDATIONS ON DIVIDEND PAYING STOCKS. THE CLIENT AUTHORIZED THE PURCHASE OF BP SHARES AND THE SALE OF A PORTION OF HIS VERIZON STOCK TO LESSEN HIS CONCENTRATION IN THAT COMPANY. THE FA ADVISED THAT THE CLIENT ALSO AUTHORIZED THE SALE OF QUEST STOCK AND THE PURCHASE OF SOME UTILITY STOCKS WITH THE PROCEEDS. AT THE TIME OF THIS PURCHASE OF BP, OUR FIRM HAD A BUY RECOMMENDATION ON THESE SHARES. WHEN OUR FIRM'S POSITION WAS REVISED TO A SELL, THE CLIENT DECIDED TO SELL HIS SHARES OF BP. THE FA STATED THAT HE NEVER BOUGHT OR SOLD ANYTHING IN THE CLIENT'S ACCOUNT WITHOUT PRIOR AUTHORIZATION. THE CLAIM WAS DENIED.
