IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations:	Firethorn and Bains have entered into a settlement agreement with the BC Securities Commission dated March 02, 2020. The result of this agreement emanated from the fact Firethorn and Bains did not fully complete an informational form with the BCSC, indicating the nature of ownership and SEC registration of Firethorn. While this information was disclosed in the ADV, SEC - IAPD website and publicly made available, it was overlooked and not captured in a timely manner on form BC 33-109F4. Bains did engage a compliance firm to manage the registration and application process, however, the responsibility for the accurateness and completeness still resides with Bains. The matter was concluded via an administrative settlement which was in excess of \$2,500. No sanctions, suspensions, revocations or orders accompanied this settlement.
