IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: Registered Representative ("RR") has been a licensed nonresident insurance producer in Indiana since February 7, 2020. On February 5, 2020, RR submitted his initial application for licensure which was approved. On June 26, 2020, RR submitted an application to add on a qualification to an existing license. The June 26, 2020, application disclosed a criminal conviction, specifically, his August 24, 2005 conviction for Battery, a Class A Misdemeanor, out of the State of Indiana. RR failed to disclose his criminal conviction on his February 5, 2020, application for licensure, which failure RR represents was inadvertent. RR's conduct is a violation of Indiana Code § 27-1-15.6-12(b)(1), which states, in part, that the Commissioner may levy a civil penalty against an insurance producer for providing incorrect, misleading, incomplete, or materially untrue information in a license application.
