Broker Statement

I deny the allegations in full. The account was set up according to the risk appetite of the client, detailed in conversations held with the client. The client later wanted to update the account with a new risk appetite in mind and we made the transactions in the account per the client's instructions. I advised this client to the best of my ability, as I do with all of my clients. The fee overcharge was an internal error. When the client's household was split in the system, the account fee was erroneously set higher than it should have been. The error was not caught immediately, but when it was discovered, I apologized and told the client that we would lower the fee going forward.
