THE DOCUMENTATION TO TRANSFER THE UBS MUTUAL FUND ACCOUNT TO PARK AVENUE SECURITIES (PAS) WAS COMPLETED AND SIGNED BY THE CLIENT. A GIAC PROSPECTUS AND PAS BROKERAGE ACCOUNT INFORMATION WERE PROVIDED TO THE CLIENT AT THE TIME THE DOCUMENTATION WAS COMPLETED AND SIGNED. THE CLIENT UTILIZED THE "FREE-LOOK" PROVISION ON THE GIAC VARIABLE ANNUITY AND RECEIVED BACK 100% OF THE AMOUNT INVESTED. THERE WAS NO TRADING DONE IN THE MUTUAL FUND ACCOUNT WHILE AT PARK AVENUE SECURITIES. THE CLIENT REQUESTED THE ACCOUNT BE LIQUIDATED. THERE WAS A GAIN ON THE MUTUAL FUND ACCOUNT OF APPROXIMATELY \$4000. MY BROKER/DEALER, PARK AVENUE SECURITIES LLC, FOUND NO EVIDENCE OF UNAUTHORIZED TRADING. THIS COMPLAINT WAS WITHOUT MERIT AND THE TRANSACTIONS WERE EXECUTED ACCORDING TO FINRA AND OUR BROKER/DEALER RULES WITH THE CLIENT'S SIGNATURES IN ALL APPROPRIATE PLACES AS REQUIRED. THERE WAS NO WRONG-DOING ON MY PART. I AM ACKNOWLEDGING THIS COMPLAINT ONLY BECAUSE I AM REQUIRED TO BY FINRA REGULATIONS. ANY ALLEGATIONS OR COMPLAINTS MADE BY AN INDIVIDUAL ABOUT A REGISTERED REPRESENTATIVE ARE REQUIRED TO MAKE NOTE OF IT, REGARDLESS IF THE CLAIM IS FRIVOLOUS OR IF THE REGISTERED REPRESENTATIVE IS DEEMED TO BE IN THE WRONG OR NOT.
