What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement I HAD THE CLIENTS SIGN A CURRENT CHECK WRITING APPLICATION FOR THEIR NFS BROKERAGE ACCOUNT IN APRIL 2010. THE APPLICATION WAS SUBMITTED IN GOOD ORDER AND IN A TIMELY FASHION BY OUR OFFICE. I WAS CONTACTED BY THE CLIENT WEEKS LATER STATING THAT THEY NEVER RECEIVED THE CHECKS OR DEBIT CARDS. I IMMEDIATELY CONTACTED 1ST GLOBAL TO INQUIRE ON THE STATUS OF THE PENDING CHECK ORDER AND I WAS TOLD THAT THEY HAD MISPLACED THE



PAPERWORK. 1ST GLOBAL SUBSEQUENTLY FOUND IT BUT INFORMED ME THAT THE NFS FORMS HAD BEEN UPDATED BY NFS IN THE MEANTIME SO I WOULD HAVE TO HAVE THE CLIENTS SIGN ALL NEW DOCUMENTATION. I PREPARED THE NEW DOCUMENTS AND HAD THE CLIENT SIGN THOSE IN JUNE 2010 AND IMMEDIATELY SUBMITTED THEM TO 1ST GLOBAL. UPON MY FOLLOW UP TO MAKE SURE THAT 1ST GLOBAL HAD RECEIVED THE NEW SET OF DOCUMENTS AND TO MAKE SURE IT WAS TO BE EXPEDITED PROCESSING ON THEIR END, I WAS TOLD THAT THE FINAL PAGE OF THE NEWLY SUBMITTED DOCUMENTS WAS MISSING. RATHER THAN GO BACK TO THE CLIENT FOR A THIRD TIME, I CHANGED THE DATE ON THE FINAL PAGE OF THE APRIL SUBMISSION TO JUNE AND FAXED THE ONE MISSING PAGE TO KEEP THE PROCESS MOVING FOR THE CLIENT. THE CLIENT'S UNHAPPINESS WITH THE WAIT FOR THE CHECKBOOK AND INEPTNESS IN HANDLING THE DOCUMENTS CONTRIBUTED TO MY FRUSTRATION BUT I REALIZE WAS NO EXCUSE FOR CHANGING THE DATE ON THE FORM.
