**Broker Statement**

I was/am an Eagle Scout and carried a Swiss Army knife as a nature of training and habit. My father got this pocket knife for me as a gift in Switzerland. When I was dropped off by my family to fly back to Chicago, I realized I had the knife moments before I went through security. I placed it in my carry on bag as previous history suggested I could mail my knife home were it to be an issue. When my bag was selected to be searched, I volunteered information that there was a swiss



army knife inside - containing a blade less than 3 inches. Unfortunately for me that day, the Airport Police chief recommended cracking down on concealed weapons. While my Swiss Army knife was not 3 inches long, as the law states for being classified as a 'concealed weapon', it was seen that way by the arresting officers and I went to jail for 15 hours on Easter Sunday. I made poor a poor split-second judgement in attempt to save an item of sentimental value.
